imaxx Short Term Bond Fund

- Focus on preservation of capital and liquidity while maximizing income
- The fund is primarily invested in money market and short term fixed income securities
- Targets shorter term Canadian bond securities with maturities typically less than 5 years
- 100% Canadian dollar
- Focus on investment grade corporate bonds, including securitized debt
- Duration neutral to underlying benchmark index
- No high yield – Average credit quality of the fund is maintained at A

imaxx Canadian Bond Fund

- Focus on delivering long-term stable returns in the form of interest income and modest capital growth by investing primarily in Canadian bonds of varying maturities and in short-term securities
- Targeting consistent benchmark out-performance 5-10bps per month (gross of fees)
- 100% Canadian dollar
- Focus on investment grade corporate bonds, including securitized debt
- Duration neutral to underlying benchmark index
- No high yield – Average credit quality of the fund is maintained at A

imaxx Canadian Fixed Pay Fund

- Focus on total return by providing a consistent stream of monthly income and some capital appreciation
- The fund invests in primarily Canadian common and preferred stocks and fixed income securities
- 5, 3, 2, 0 cents per unit per month distribution options available
- All-in-one solution offering stable income and potential for capital growth
- Suitable for investors looking for tax efficient income of return of capital, capital gains and dividends
- Fund has demonstrated strong and consistent returns since inception versus peer group
- Up to 30% of the fund's portfolio may be invested in foreign issuers

imaxx Canadian Dividend Plus Fund

- Focus on providing strong long-term total return, and mitigating risk through a deeply diversified portfolio of primarily Canadian equities
- With a focus on higher quality securities, the fund emphasizes exposure to companies that are able to consistently grow their dividends
- For diversity, the fund may also invest in fixed income securities, investment trust units and other income paying investments including convertibles and preferred stocks
- 4 and 0 cents per unit per month distribution options available
- Up to 30% of the fund's portfolio may potentially be invested in foreign issuers

imaxx Equity Growth Fund

- Focus on generating long-term capital growth by investing in a diversified portfolio of primarily North American equity securities
- Growth potential, valuation, quality, and dividends are captured in the selection of securities
- With a focus on higher quality securities, the fund emphasizes exposure to companies that are able to consistently grow their dividends.
- Focus on medium to large capitalized companies
- Up to 49% of the fund's portfolio may be invested in foreign issuers
